Any person who is not of Ukrainian descent, but who meets other requirements of Section 1 and is married to a person of Ukrainian descent will be eligible for full membership in the Ukrainian American Veterans, Inc.

Any person who meets the eligibility for membership in the Ukrainian American Veterans, Inc. but who resides in a locality where there is no established Post may apply as a Member-at-Large. An application will be submitted to the National Executive Board for final approval. A Member-at-Large shall be entitled to all rights and privileges.
